LAW ENFORCEMENT BASIC SNIPER CERTIFICATION COURSE

- Why we implement a Screening Exercise -

The LE-BSC course is designed to graduate a well-rounded officer capable of immediately integrating with their agency team in the role of Sniper/Observer.

*This course has a mandatory screening exercise on the beginning of Day 1 that must be completed with a passing score in order to attend the remainder of the class.

The purpose of this screening is to insure the attendee is capable of meeting at least minimum levels of physical and basic weapon proficiency prior to entering the main course. Our class can only proceed as fast as the slowest officer. We are trying to compress 3 to 4 weeks of material into 5 days. To successfully accomplish this, we absolutely have to stay on track with every aspect of the class so that the instruction can relayed, absorbed and tested

In past courses here have been repeated instances of attendees arriving totally unprepared to a degree that the entire class suffered. **We must establish a minimum start condition** to insure EVERYONE is as capable as possible upon completion of the course.

Anyone failing the pre-class screening exercise will be given <u>one</u> opportunity to immediately retest while the balance of the class precedes into the next portion of the course. If the officer successfully passes the re-test, they can re-integrate into the class and attempt to catch up on any material or exercises they were not present for.

Any officer not passing the pre-class screening after 2 attempts, cannot proceed into the main course and will not be certified by 1 Mil Right LLC. They will be invited to audit the remainder of the course as an observer if they choose to do so. If the officer elects to leave the course after failing the screening, 1 Mil Right would refund any tuition paid within 7 days.

The pre-class screen is a 20 shot exercise. A copy of the exercise is available upon request by emailing Terry@1MilRt.com and referencing this class.

Passing the Pre-Entry Screening will green light the officer to proceed into the main course only. It does not guarantee the officer will pass the certification process.

Participation by officers completing the Pre-Entry Screening Exercise does not automatically guarantee the officer will receive their certification from 1 Mil Right LLC at the end of the week.

This 1 week course includes physical tests, written tests and marksmanship tests that must be completed in a satisfactory manner in order to graduate and receive certification. We have to document the training and testing of all phases. These standards are in place for your safety as well as the safety of your fellow officers and citizens that may become involved with you while in your role as a Sniper / Observer.

We DO NOT want to fail anyone. We want everyone to succeed and become a strong team member. We will help you in any way we can to do that.
